The Powers of War and Peace - John Yoo 2008-09-15

Since the September 11 attacks on the United States, the Bush administration has come under fire for its methods of combating terrorism. Waging war against al Qaeda has proven to be a legal

quagmire, with critics claiming that the administration's response in Afghanistan and Iraq is unconstitutional.
